

Canada operates a highly developed mixed economy, ranking 9th globally with a nominal GDP of US\$2.23 trillion in 2025 and a GDP per capita of approximately US\$65,710.

Canada's fiscal prudence is notable, with its net debt-to-GDP ratio remaining among the lowest within G7 countries, while maintaining strong credit ratings of AAA from Standard & Poor's and Aaa from Moody's.



Canada's proactive approach to trade agreements demonstrates its commitment to fostering a resilient and globally integrated economy, further solidifying its position as an aspirational nation.

Natural Resources: Economic Cornerstone



In 2023, natural resources contributed an impressive \$464 billion to Canada's real GDP, accounting for 21% of the national GDP and supporting 3 million jobs—15% of total employment—with annual wages averaging \$25,000 above the national average.


Resource Sector: Productivity Powerhouse

Driving Economic Efficiency

The natural resources sector's productivity rate is 2.5 times greater than that of the overall economy, with oil and gas extraction notably contributing \$356 GDP per hour.

This high productivity, coupled with \$2 billion invested in Research and Development (R&D) in 2022, indicates that the sector is not merely extractive but a highly efficient and innovative engine for economic growth.



Canada's diversified mineral endowment, which includes critical minerals essential for clean energy applications and advanced technologies, positions it as a crucial player in the global transition to a green economy.

The demand for critical minerals is expected to rise with the growth of electric vehicles, infrastructure, and defense spending, creating hundreds of thousands of high-paying jobs across the country, including for Indigenous communities.

The Domestic Challenge: Affordability

The Perception Gap

While Canada is globally admired for its safety and stability, rising costs of living and housing affordability issues are impacting the perceived quality of life domestically.

This gap between global perception and internal experience suggests that while Canada possesses strong foundational elements, increasing pressure on affordability could erode its long-term appeal as a destination for talent if not addressed.




Work-Life Balance: Leading the Americas



Canada secured an impressive 7th ranking out of 60 countries, standing as the only nation from the Americas in the top 10, far outperforming the U.S. which ranked 59th.

Education Excellence: Human Capital Advantage



A remarkable 92% of adults aged 25-64 have completed upper secondary education, significantly surpassing the OECD average of 79%. Canadian students consistently perform well in international assessments, with Canada ranked 4th globally in "Best Countries for Education in 2022".

Health and Wellbeing: Exceptional Standards

- 52.2% of Canadians report very good or excellent health (1st in OECD, 2023)

Peacekeeping Legacy: Global Leadership

Historical Commitment

Lester B. Pearson, then Canadian Minister of Foreign Affairs, was a prominent figure in the inception of modern peacekeeping, earning the Nobel Peace Prize in 1957 for his role in mediating the 1956 Suez Canal Crisis.

From its inception until 1989, Canada participated in every UN peacekeeping effort, providing the most UN peacekeepers during the Cold War, with over 125,000 Canadians serving in international operations.

Charter of Rights and Freedoms: Constitutional Values

Foundational Document

The Canadian Charter of Rights and Freedoms, enshrined in the Constitution in 1982, is a foundational document for Canadian values and a powerful symbol of national unity.

- Explicitly recognizes the value of multiculturalism (Section 27)
- Guarantees equality before the law, human rights, and gender equality
- Provides a stable and enduring framework for social justice

Canadians take pride in encouraging all citizens to honor their own cultures, with core values including equality, respect, safety, peace, and an appreciation for nature.




